In such an event, the successful bidder shall be bound to produce the additional bid security within seven (07) days from the issuance of letter of acceptance failing which the Client / Procuring Agency shall forfeit the bid security of the successful bidder and may initiate legal action against the bidder.
- iv) The application must be accompanied with earnest money @ 2% of the total estimated cost in the form of call deposit/bank draft (Refundable) drawn in the favour of Director General, Pakistan Sports Board, Islamabad.
