**CORRIGENDUM**


Reference is made to the tender notice regarding the works:

1. Supply, Installation, Testing and Commissioning Of Electronic Display & Scoring System at Different Facilities of Pakistan Sports Complex, Islamabad;
2. Supply Installation, Testing and Commissioning of Electronic Timing System Devices in the premises Of Pakistan Sports Complex, Islamabad;
3. Supply Installation, Testing And Commissioning Of Diesel Generating Set (03 Sets) at Pakistan Sports Complex, Islamabad;

by the Pakistan Sports Board, Islamabad appeared in daily newspapers vide PID No(I)6324/24 dated 15<sup>th</sup> March, 2025. In the advertised / uploaded bidding documents, following amendments are hereby made through this corrigendum only in respect of work *“Supply Installation, Testing And Commissioning Of Electronic Timing System Devices In The Premises Of Pakistan Sports Complex, Islamabad”* at serial No. 02 above.

- a. Initially planned **timing devices (02 No)** for swimming pools have been reduced to only **one timing device** for a single swimming pool and accordingly in **VOLUME-II: Price Bid - Bidding Documents** at Page 1 of 2, Line No. 4: **“Timing System for 2xSwimming Pool System”** and Page 2 of 2, Last Line **“Total Price For 02 No. Swimming Pools”** shall be deleted
- b. The already required **PEC contractor Category (C2)** have been replaced with **PEC Category (C3)** as previously mentioned in **Volume – I of Technical bid–bidding documents** Instructions to bidders, sub-clause 2.1 of IB-2 eligible bidders (Page No. IB-1) and sub-clause 13.4 of IB 13 (Page No. IB-6).
- c. Previously required **Bid Security** of an amount not less than **10,000,000/-** in Pak Rupees, as mention in sub-clause 15.1 of IB-15 (Page No. IB-8) shall be replaced with **Bid Security** of an amount not less than **6,000,000/-** in Pak Rupees.
- d. Already required **“Average Annual Construction Turnover for Last 3 years must be greater than PKR 450 Million”** and **“Update Working Capital (Current Assets – Current Liabilities) must be greater than PKR 150 Million”** shall be replaced with **“Average Annual Construction Turnover for Last 3 years must be greater than PKR 300 Million”** and **“Update Working Capital (Current Assets – Current Liabilities) must be greater than PKR 100 Million”** respectively.
- e. These addition / deletion / amendments will form an integral part of the Bidding Documents. The Bidder shall acknowledge the receipt of this addendum to the Employer. The original of addendum shall be attached with the original bound Volume of the Bidding Documents and the Bidder shall note & take into consideration while preparing the subject bid.

The last date for submissions of the bids for above three tenders at serial No 01, 02 and 03 above, is extended up to **21<sup>st</sup> April, 2025** and will be opened on the same day. Other terms and conditions will remain the same.
