

INSTRUCTIONS TO BIDDERS

In addition to the essential guidance/instruction (provided through the cover letter) vis-à-vis application for the bids, the followings are also to be considered integral part of the bidding documents and may be read and followed carefully before submission of bid/ proposal.

A. General

1. Scope of Bids: PSB upload Bid document on EPADS to the bidders interested for participating in the subject tender.
2. Eligible Applicants: A firm/company shall be a legally established entity or a firm.
3. **Scope of services**
Supply and installation of computer system, E-gaming chairs, table, wall paneling and carpets etc at Pakistan Sports Board, Sports Complex, Islamabad.

B. Preparation of Applications

1. Evaluation of Bids/Mandatory Requirements for Bidders:

1. The firm should be registered with Income Tax and Sales Tax Departments (Registration Numbers should be clearly mentioned and valid documentary evidence be attached). The registered contractor/firm who is on active Tax Payer list (ATL) of FBR is eligible to submit bids.
2. The bids/proposals shall be submitted under single stage two envelopes procedure containing **Technical and Financial** bids will be processed through EPADS as per PPRA Rule.
3. Proof of previous specific working experience i.e. IT and Furniture for the last 2 years. Respective work orders / completion certificates / Authorized dealership / Sole preparator etc must be attached.
4. Income tax returns last two years minimum must be submitted to show the financial strength / position of the firm / company.
5. Audit Statement for the last two years must be attached.
6. The technical bid should have the profile of company only and financial bid have only rates as per specification including all taxes.
7. All those companies / firms are eligible to apply who has prior specific work experience of related nature of job.
8. Conditional tenders shall not be accepted. Any tender containing addition / alternation in the above terms and conditions and the specifications of items / services will also not be considered.
9. The quantities of items may be increased or decreased as per the requirement.
10. The firm should have not been black listed by any Government Department or Semi Government Department in the past. The declaration made by the bidder towards non-blacklisting on judicial stamp paper should be enclosed.

11. Pay Order/Bank Draft/Bank Guarantee amounting to Rs.150,000/- must be attached as earnest money / bid security (attached/upload scanned copy with profile) in the name of "Pakistan Sports Board" and original will be submitted to Assistant Director (Procurement), PSB before opening the bid.
12. Bid Security of successful bidder will be withheld till completion of the assignment. While the bid security of unsuccessful companies will be returned.
13. An agreement shall be made on stamp paper duly issued by Treasury of Pakistan between the company / firm and Pakistan Sports Board after placing work order etc. The stamp paper will be provided by the successful firm / company.
14. The bids will be evaluated upon criteria and requirements defined in Evaluation Criteria mandatory.
15. In case of any holiday or any disturbance on the opening of tender, the tender will be opened on next working day as per schedule.
16. The completion time of the said work is fifteen days (15) after issuance of work order to the successful firm / company.
17. The DG, PSB being the authority to accept or reject any or all the proposals as per PPRA rules.
18. Any bidder or firm shall be disqualified from participation in the bidding process if:
 - (a) the bidder or any of its directors, partners, or authorized representatives is currently under departmental inquiry, disciplinary proceedings, or has been blacklisted by the Pakistan Sports Board or any other Government organization;
 - (b) the bidder or any of its affiliates is involved in any dispute, litigation, or court proceedings against the Pakistan Sports Board; or
 - (c) the bidder has been found engaged in any fraudulent, corrupt, coercive, or collusive practice, whether in connection with this procurement or any other previous contract with PSB or any public sector entity.
